



Based on the Fund's portfolio returns as at June 30 2025, the Volatility Factor (VF) for this Fund is 9.9 for USD Class (Moderate), 9.8 for MYR Class (Moderate), and 10.2 for SGD Class (Moderate) (source: Lipper).
