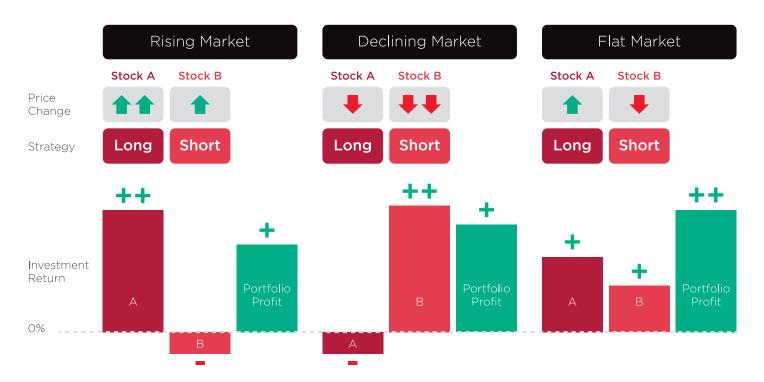

Market Neutral Explained

A market neutral strategy aims to provide **consistent positive returns** regardless of what is happening in the broader market.

By going long on securities expected to outperform and short on those likely to underperform, the strategy seeks to **neutralise overall market exposure**.

For investors, this helps reduce portfolio volatility, enhance diversification, and generate more stable returns across market cycles.

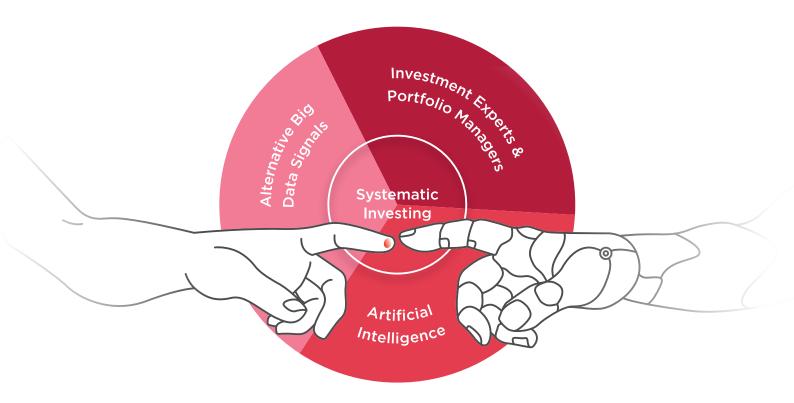

	While the Fund is highly invested in the Target Fund, we will ensure that the Fund has sufficient liquidity to meet repurchase requests made by Unit Holders. As a feeder fund that invests predominantly in the BlackRock Systematic Global Equity Absolute Return Fund, we do not intend to take temporary defensive position for the Fund during adverse market, economic and/or any other conditions. This is to allow the Fund to mirror the performance of the Target Fund in all market conditions. However, BlackRock may take temporary defensive position when deemed necessary.
