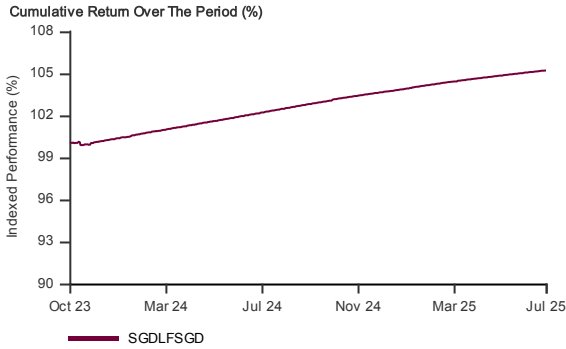

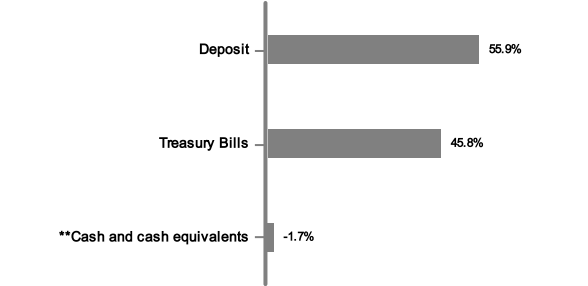

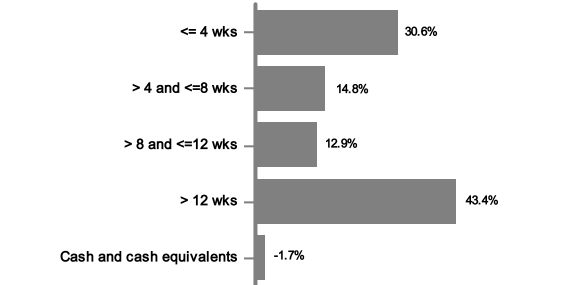
Target Fund Asset Allocation as at June 30 2025#
