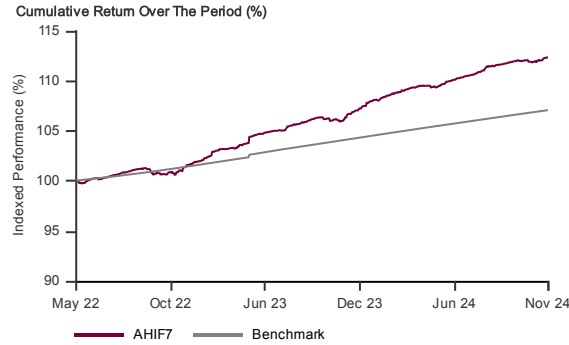

## Performance Record as at November 29 2024\*

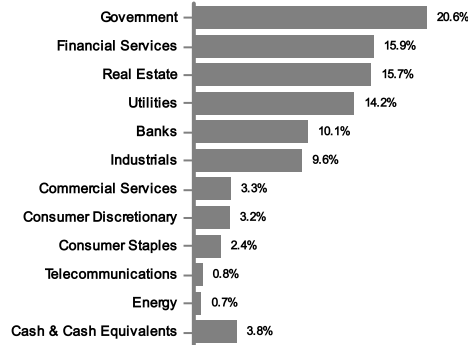

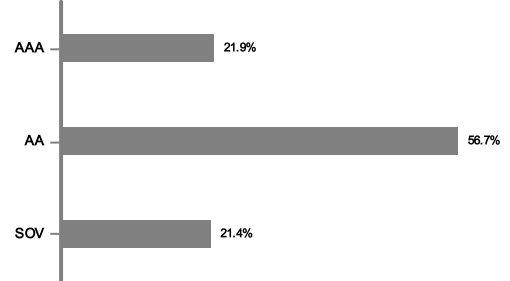
