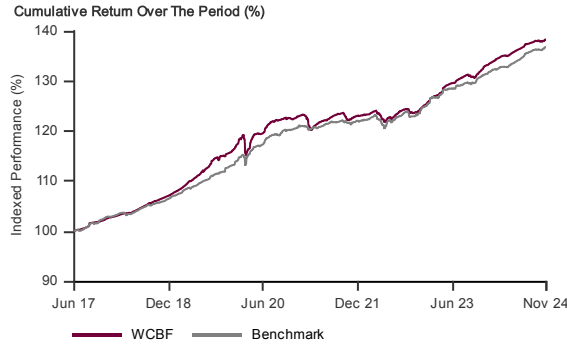

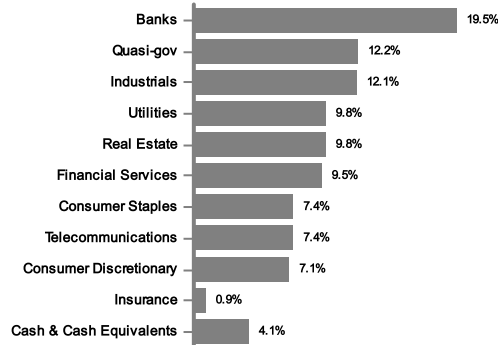

Sector Allocation as at November 29 2024*

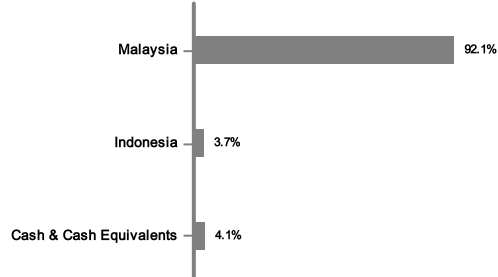


Credit Profile as at November 29 2024*
