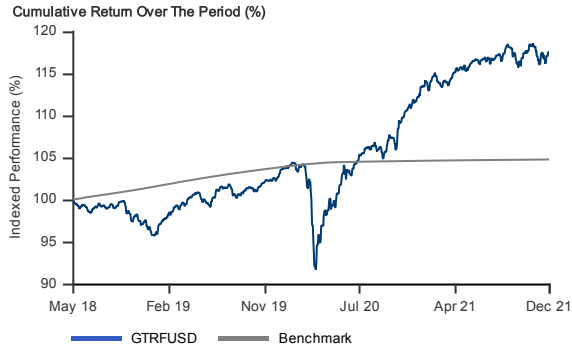

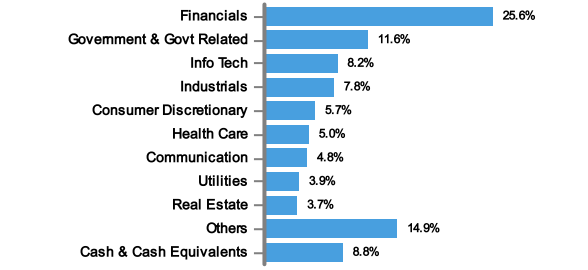

 Based on the Fund's portfolio returns as at 30 November 2021, the Volatility Factor (VF) for this Fund is 4.9 for USD Class (Low), 5.9 for MYR Hedged Class (Low), 6.4 for SGD Hedged Class (Low), 13.6 for AUD Hedged Class (Moderate), 11.8 for GBP Hedged Class (Moderate), 8.2 for EUR Hedged Class (Low), 6.5 for RMB Hedged Class (Low), and 21.2 for HKD Hedged Class (Very High) (source: Lipper). Very Low includes Funds with VF that are not more than 4.265. Low includes Funds with VF that are above 4.265 but not more than 10.84. Moderate includes Funds with VF that are above 10.84 but not more than 14.24. High includes Funds with VF that are above 14.24 but not more than 17.285.
