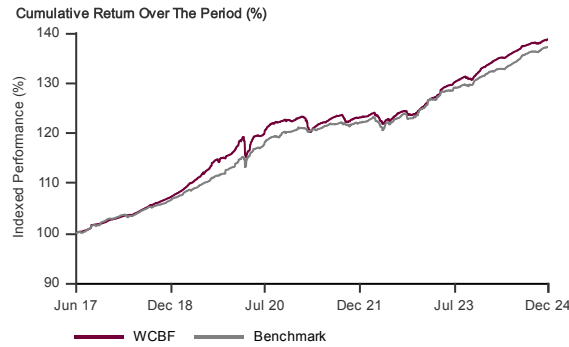

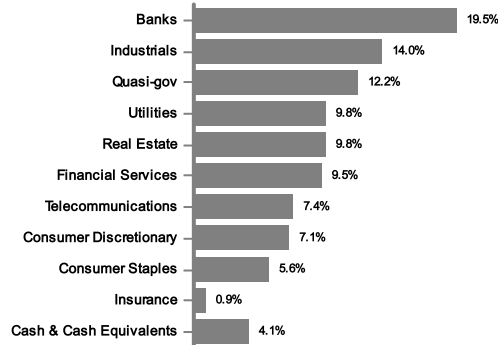

Sector Allocation as at December 31 2024*

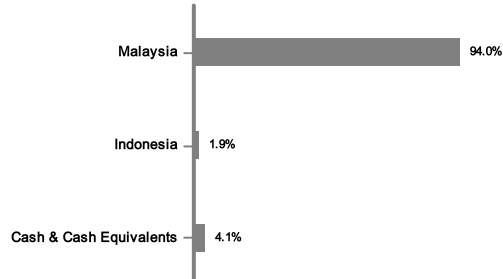


Credit Profile as at December 31 2024*
