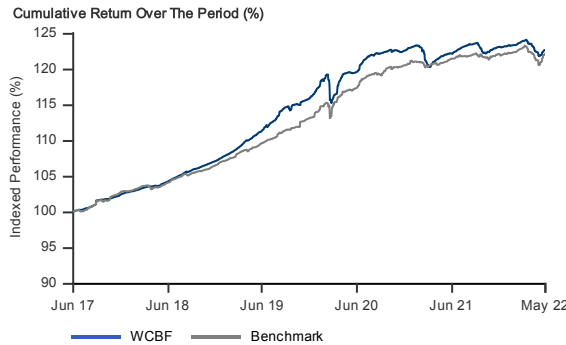

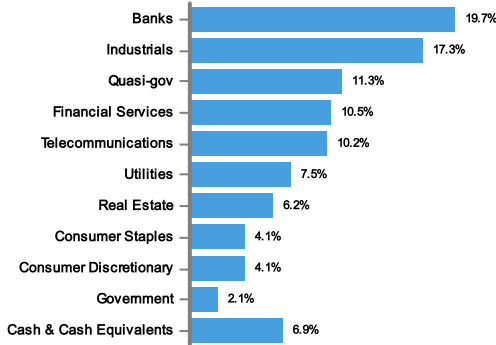

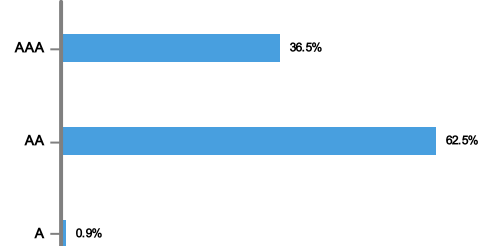

Sector Allocation as at 31 May 2022*

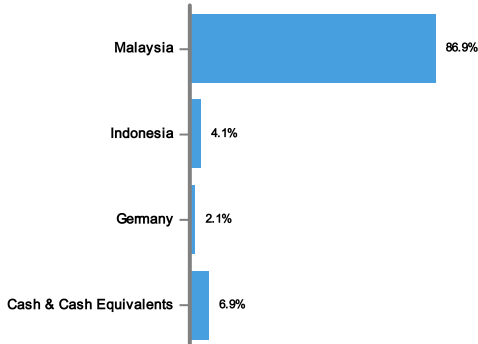


Credit Profile as at 31 May 2022*
