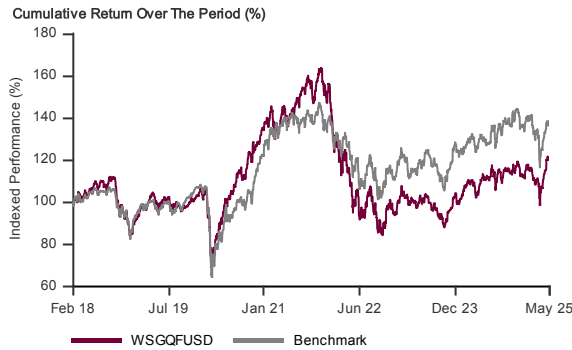

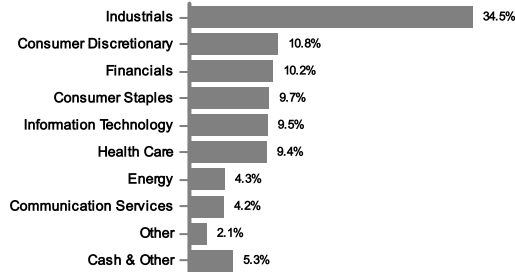

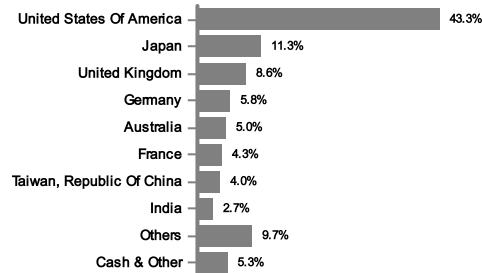

Based on the Fund's portfolio returns as at April 30 2025, the Volatility Factor (VF) for this Fund is 17.1 for USD Class (Very High), 17.0 for MYR Class (Very High), 18.8 for MYR Hedged Class (Very High), 17.6 for SGD Class (Very High), 17.7 for AUD Class (Very High), and 17.8 for GBP Class (Very High) (source: Lipper). Very Low includes Funds with VF that are not more than 4.73. Low includes Funds with VF that are above 4.73 but not more than 9.185. Moderate includes Funds with VF that are above 9.185 but not more than 11.98. High includes Funds with VF that are above 11.98 but not more than 16.345. Very High includes Funds with VF that are above 16.345. The VF means there is a possibility for the Fund in generating an upside return or downside return around this VF. The Volatility Class (VC) is assigned by Lipper based on quintile ranks of VF for qualified funds.
