

Based on the Fund's portfolio returns as at September 30 2024, the Volatility Factor (VF) for this Fund is 16.0 for USD Class (High), 15.9 for MYR Hedged Class (High), 16.8 for SGD Hedged Class (Very High), and 21.2 for AUD Hedged Class (Very High) (source: Lipper). Very Low includes Funds with VF that are not more than 5.04. Low includes Funds with VF that are above 5.04 but not more than 9.025. Moderate includes Funds with VF that are above 9.025 but not more than 12.075. High includes Funds with VF that are above 12.075 but not more than 16.265. Very High includes Funds with VF that are above 16.265. The VF means there is a possibility for the Fund in generating an upside return or downside return around this VF. The Volatility Class (VC) is assigned by Lipper based on quintile ranks of VF for qualified funds.
