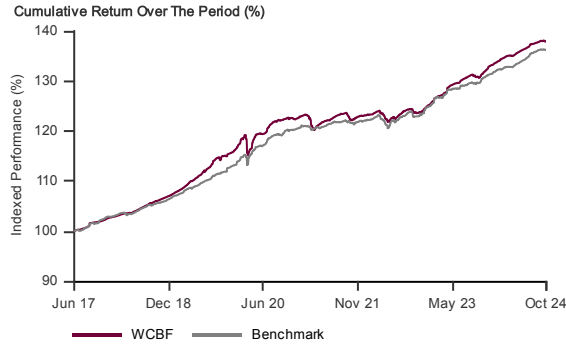

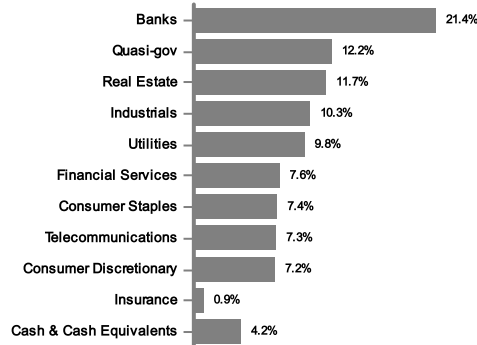

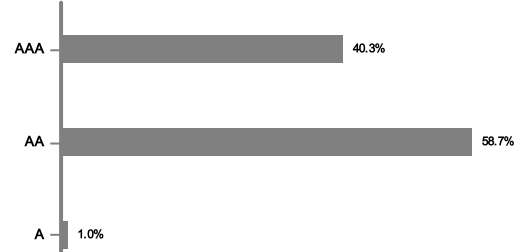

Sector Allocation as at October 30 2024*

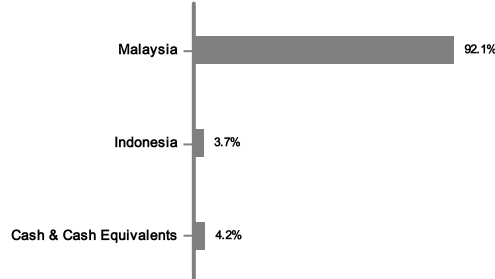


Credit Profile as at October 30 2024*
