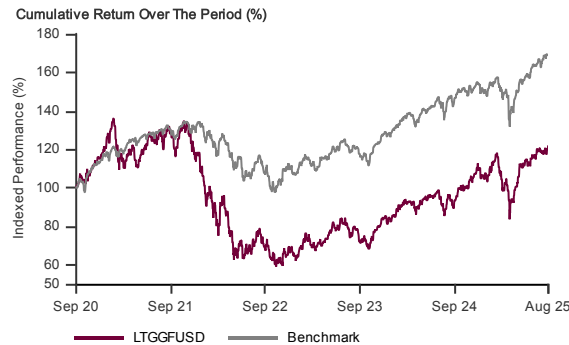

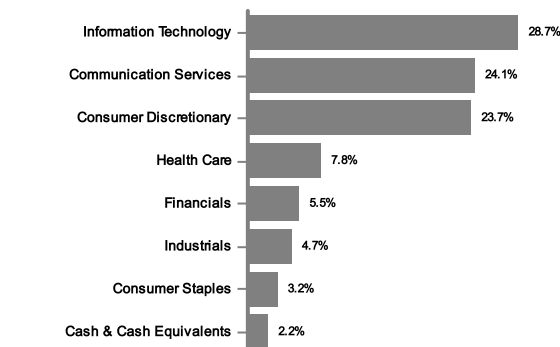

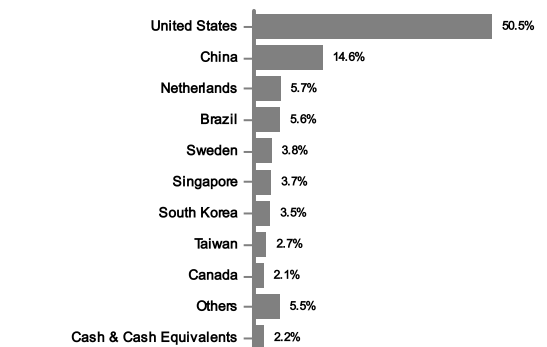

Based on the Fund's portfolio returns as at July 31 2025, the Volatility Factor (VF) for this Fund is 19.4 for USD Class (Very High), 21.5 for MYR Hedged Class (Very High), 20.7 for SGD Hedged Class (Very High), and 24.2 for AUD Hedged Class (Very High) (source: Lipper). Very Low includes Funds with VF that are not more than 4.555. Low includes Funds with VF that are above 4.555 but not more than 8.645. Moderate includes Funds with VF that are above 8.645 but not more than 11.29. High includes Funds with VF that are above 11.29 but not more than 15.295. Very High includes Funds with VF that are above 15.295. The VF means there is a possibility for the Fund in generating an upside return or downside return around this VF. The Volatility Class (VC) is assigned by Lipper based on quintile ranks of VF for qualified funds. Presently, only funds launched in the market for at least 36 months will display the VF and its VC.
